# **Entry Requirements**

# 1.2 Entry Requirements

No permit is required for non-commercial flights of foreign GA aircraft into and from the territory of the Republic of Lithuania.

### 1.2.1 Border Crossing

Aircraft operating in controlled airspace may cross the border area of Lithuania on ATS routes or on other routes pre-coordinated with and authorised by the ATS provider.

Aircraft operating in uncontrolled airspace of the border area with the Russian Federation and Belarus may cross the Lithuanian state border only at its borderline reporting points.

Aircraft operating in uncontrolled airspace of the border area with Schengen States may cross any point of the Lithuanian state border.

# 1.2.2 Aerodromes of Entry

International flights may be operated to and from Lithuanian aerodromes where border, customs, medical quarantine, hygiene control and other procedures are followed.

This provision is not applied to flights operated between Lithuania and other Schengen States, except for the cases when the internal border control is temporarily resumed in Lithuania.

# 2.1 Regulations

# 2.1.1 Airspace Classification

JEPPESEN 21 NOV 14

Within Vilnius FIR Airspace Classes (C), (D), and (G) as detailed in General Part section 2.3 ATS Airspace Classification are used with exceptions as follows:

Within Class (G) airspace at and below 3000':

- I Clear of cloud and in sight of the surface;
- Flight visibility 5 KM.

Flights shall be permitted when visibility is not less than 1500m, provided that:

- speeds of 140 KT IAS or less to give adequate opportunity to observe other traffic or any obstacles in time to avoid collision;
- circumstances in which the probability of encounters with other traffic would normally be low, e.g. in areas of low volume traffic and for aerial work at low levels.

HEL may be permitted to operate with a flight visibility not less than 800m, provided that manoeuvring is performed at a speed that will give adequate opportunity to observe other traffic or any obstacle in time to avoid collision.

# Regulations

cer issued in accordance with the conditions and procedure established by the Commander of the Lithuanian Armed Forces (not applicable to international flights and flights of state aircraft).

The requirements do not apply to flights of all ACFTs operating in a ATZ within the border area.

Permits for flights of civil aircraft are issued upon submitting a filled application form by an aircraft pilot to the Air Force. Application forms for flights may be submitted via Fax (837) 307592, 399027 or E-Mail: kopob@mil.lt.

Application form for permit and the procedure for issuance of permits for flight of civil aircraft in the border area are described in the AIC A 011/2014 of 15 May 2014. Both AIC and application form can be found on www.ans.lt >For Aviation Community.

# 2.1.2 Special Airspaces

In Class (G) Aerodrome traffic zones (ATZ) and Traffic information zone (TIZ) are assigned to Radio mandatory zones (RMZ).

# 2.1.2.1 Radio mandatory zones (RMZ)

In RMZ pilots shall maintain continuous air-ground voice communication watch and establish two-way radio communication, as necessary, on the appropriate communication channel. Before entering RMZ, a pilot shall establish radio communication and transmit call sign, type of aircraft, position, level, and intentions of the flight.

If an aircraft is not supplied with the radio equipment, flying within ATZ may be permitted upon prior coordination with aerodrome owner or operator.

#### 2.1.2.2 Border Area

The border area is part of the Republic of Lithuania's uncontrolled airspace stretching out for 4NM into the territory from the Republic of Lithuania's state border with a non-European Union state.

When the internal border control is resumed, the border area is part of the Republic of Lithuania's airspace stretching out for 4 NM from the Republic of Lithuania's state border into the territory.

Civil aircraft and state aircraft may operate in the border area on condition that:

- a flight plan has been submitted;
- the ACFT is equipped with a radio communication facility:
- the ACFT is equipped with a transponder operating in Mode A/C or Mode S (not applicable to glider flights).
- a flight permit has been received from the Commander of the Air Force or his authorized offi-





# 2.4 Flight Planning and Preparation

# 2.4.1 Flight Plan

# 2.4.1.1 Submission of FPL

A FPL shall be submitted prior to operating:

JEPPESEN 4 SEP 09

- a. any flight or portion thereof to be provided with air traffic control service,
- b. any IFR flight in controlled airspace,
- c. any flight within or into designated areas, or along designated routes, when so required by the appropriated ATS authority to facilitate
- the provision of flight information, search and rescue services and to alert in cases of emer-
- the coordination with appropriate military units or with air traffic service units in adjacent States in order to avoid the possibility of interception for the identification purpose,
- d. any flight within the Lithuanian border 15 KM width zone,
- e. any flight across international borders.

#### 2.4.1.2 Time of Submission

A FPL shall be submitted to the ATS provider:

- not later than 30 minutes before departure of flights in the airspace of Lithuania,
- not later than 3 hours before international flights in which routes there are Integrated Initial Flight Plan Processing System (IFPS) areas,
- not later than 1 hour before the international flights in which routes there are no IFPS areas.

Air Filed Flight Plans (AFIL) are to be submitted:

- not later than 10 minutes before entering controlled or advisory airspace,
- not later than 5 minutes before entering aerodrome control zone or traffic information zone.

### 2.4.1.3 Closing of FPL

- a. In cases when it is known that the arrival aerodrome does not possess sufficient communication devices and there are no other ground means to announce the arrival before landing to a corresponding ATS, the aircraft has to pass the information analogous to the arrival message during the flight. Such information is to be passed to such an aviation station, which provides information for the ATS, which is responsible for the FIR, where is the mentioned aircraft.
- b. In cases of the aerodromes that have no air traffic control services, the arrival message must be submitted by phone to the nearest ATS during 30 minutes:

NOTE: If there is no message about the closing of the FPL after expiry of 30 minutes, the search and rescue operation will be started.

- c. If the aircraft lands at the aerodrome which is not a destination point (diverted landing), the local ATS is to be informed accordingly.
- d. In absence of a local ATS unit at the aerodrome of diverted landing the arrival message shall be transmitted to the destination aerodrome.

## Arrival reports shall contain:

- aircraft identification,
- departure aerodrome
- destination aerodrome (departure at alternative aerodrome only),
- arrival aerodrome,
- time of arrival.
